

## **Tir Prince Market**

## **2024 Traders Information**

- Please provide a copy of your Public Liability Certificate to the Gate Box the first time that you trade, it is the trader's responsibility to ensure this cover is valid at all times. Certificate to be available on pitch/stall on request at all times. Food, drinks, cosmetics, topical products (i.e. products applied to the skin) must be covered by your insurance. Insurance certificates can also be sent to market@tirprince.co.uk
- 2. All traders must pay in full online or over the phone. Pre-bookings and deals are only available (online or over the phone) until midday the Thursday prior. Casual rates and admin charges apply on the gate.
- 3. All traders must provide the registration number of their primary vehicle.
- 4. Food traders must comply with all Local Authority Registration requirements, and a copy of the Food Standards Agency certificate must be given to the Gate Box the first time that you trade and displayed on the pitch whilst trading. No products to be sold beyond the "use by" date. Customer notice must be displayed for any products sold beyond the "best before" date. Allergen information must be displayed. All relevant documentation must be made available on request. The sale of any drinks is not permitted other than by the agreed concessions
- Ensure you stay within your stalls' boundary markers and do not encroach into the aisles, financial penalties could be applied. For public health & safety, ensure all stalls, tables, equipment etc is safely secured and wind resistant
- 6. Ensure van storage numbers are displayed prominently, on vehicles, at all times. The Management reserves the right to remove any storage van not displaying a number. All storage is for Tir Prince Market use only on Tir Prince Market Days, not other venues. Storage is for named traders and not to be shared or sublet. Loss of storage or other facilities may be applied
- Ensure the stall numbers are displayed at all times, all traders who continually fail to display their stall numbers will not be offered Gate Deals. Any pre paid traders who do not display their stall numbers could face a surcharge.
- Full rents will be charged for all traders missing Saturdays & Sundays between between 30th March - 14th April, 20th July - 25th August, 19th - 27th October 2024
- 8b. No holidays will be granted by Tir Prince Management during these periods and full rents will be payable for traders not attending.
- 9. Half rents will be charged for all traders missing Saturdays and Sundays on all other dates other than those listed above unless a full 2 week notice in writing is given to Management of any proposed absence. Management reserves the right to refuse any absence requested, which is limited to a maximum 2 weeks/weekends holiday in total, absence to operate other venues incurs full rent at casual rates, excessive absence may result in loss of pitch. Extenuating circumstances to be discussed on merit.

- 10. Full rent will be charged to any trader who leaves their stall built up, leaves any vehicle on their pitch or any other obstruction on their pitch without authorisation. This will be applicable at all times of the year including Wednesdays, Fridays and Bank Holiday Mondays.
- 11. Any trader who is not present by 7am must be aware that their pitch may have been reallocated for that day.
- 12. The Management reserves the right to amend the rules and regulations of the market at any time.
- 13. Stalls to the left of the Main Gate can only be left assembled whilst the market is open Wednesday and Friday if the weekly gate deal is paid unless otherwise agreed by Management.
- 14. Stock must not be left in stalls overnight without prior permission from the Management. Please note additional charges may apply if permission is granted.
- 15. In the interests of health & safety, all traders must remove, all of their rubbish offsite at the end of each market day as the bins onsite are for the use of the general public only. Fines apply for non-compliance
- 16. All pitches should be left clean and tidy and all rubbish removed from site, a mimum £50 penalty will be issued to anyone whose pitch is left untidy and repeat offenders could lose their pitch.
- 17a E-cigarettes/vapes and associated products as well as any other age restricted products (DVDs, aerosols, party poppers etc) can be sold only by agreement from Tir Prince management. Traders' responsibility to ensure no underage sales (as per government restrictions). Age restriction signage must be displayed and must be clearly visible and legible. Traders must be able to show due diligence, and must comply with UK and local legislation.
- 17b Sales of tobacco, alcohol, fireworks, illegal substances, counterfeit products, (perfumes and other general goods) or any other restricted products (medicines, bladed articles etc) completely prohibited. No exceptions. This list is not exhaustive and encapsulates any and all prohibited and/or inappropriate products. BB guns and associated products are restricted and can only be sold with prior approval from Tir Prince Management. If permitted, your insurance must explicitly state the products you are selling.
- 18. Traders must not drive vehicles off or around the market during operational times, unless agreed upon by Tir Prince management. Scooters, electric/pedal bikes, skateboards and similar are not permitted on the market.
- 19. All terms apply from Market opening until closure and apply to all reserved positions inclusive of regular, Gold, car boot, shops/units etc.
